Clinical Activities

Dr. Smith is a nationally recognized clinician with special expertise in < >. She has a busy clinical practice, and receive excellent Press Ganey scores from her patients. Research and Scholarship

Dr. Smith is a productive investigator who has made important original contributions in the area of < >. She participates in NIH and other federal scientific review panels. Dr. Smith coordinated a study with our national society to select and identify collaborators chosen from 30 academic institutions to assist in the study of < >, which resulted in three publications in the journal of our specialty. She is an extraordinary mentor who has guided many residents, fellows and junior faculty to successful careers as physician-scientists. As Director of our Residency Program, Dr. Smith has developed the curriculum, arranged the rotations and continues to recruit excellent candidates into our residency program. Our program is recognized as one of the best in the nation, and our residents consistently give Dr. Smith excellent evaluations. She also supervises fourth year students in their clerkships. She is a much sought after speaker at faculty development sessions for trainees and junior faculty.

Administration, Service, Diversity and Inclusion, Professionalism

As Vice Chair, Dr. Smith is a strong partner in my efforts to move our Department forward. She is an active recruiter of talented new faculty as well as high quality residents and fellows. Her leadership in on our diversity and inclusion efforts has resulted this year in the highest percentage of entering URIM housestaff in New York State.

In addition to being a good institutional citizen (as detailed on her CV under committee memberships), Dr. Smith generously contributes her time beyond Mount Sinai. As a member of the New York State Chapter of < Y >, she uses her knowledge and experience to support change and improvements in health law for New York State. She was also the clinical consultant on a national panel assembled by the < > to review policy on < >. Last year, she was selected as the primary presenter on < > at an NIH Round Table, which resulted in the implementation of < >.
