

Federal and State Electronic Submission and Grants Management Systems that Require Grants and Contracts Office (GCO) Registration or Approval

I. Introduction

This memorandum is designed to help users navigate through the on line registration and approval processes and grants management systems for federal and state funded projects. For private foundations and associations that require GCO engagement with their submission system, please do consult their instructions for more information.

 - A. Instructions
 - 1. Register in advance by sending an e-mail to grants@mssm.edu with the person's first, last name, e-mail address and role. See the roles in Table 2.
 - Additional Instructions for Federal Agencies
 These additional instructions are for federal agencies only (i.e., not New York State) and the following individuals:
 - a. PIs of Competitive, Single Project Federal Grant Applications
 - b. Project Leaders of Project/Cores on Multi-Project NIH Competitive Applications
 - c. Postdocs, Graduate or Undergraduate Students participating at least one personmonth of full-time work on the project in the current budget period of RPPR Applications
 - d. Sponsors (i.e., Mentors) on NIH/AHRQ Fellowships
 - e. Trainees on NIH/AHRQ Research Training, Fellowship, Education, and Career Awards
 - f. Users who wish to gain access to the on line system

After registering and receiving a username and temporary password by e-mail, individuals in a. e. above must also log into eRA Commons and complete the required fields in their <u>personal profile</u>. Failure to do so will result in the agency's inability to accept the application.

Do not register in grants.gov or System for Award Management (SAM). Mount Sinai is already registered as an institution.

3. Additional Instructions for Modifying or Adding Roles in ASSIST and eRA Commons To modify or add a role of an already existing user, please send an e-mail to grants@mssm.edu with the person's name and details of the request.

Users may have multiple NIH user roles. For example, it is possible to be a PI on a NIH R01 and a Sponsor on a postdoc's F32 fellowship. Users may also be affiliated with multiple institutions. Please note that an individual will need two eRA Commons accounts is if he/she is both a PI and a Signing Official (i.e., Authorizing Organization Representative) at an institution.

Table 2 – eRA Commons and ASSIST User Role Table

Role	Additional Information
ASST	The PD/PI can <u>delegate</u> an assistant to perform tasks such as editing and viewing RPPR proposals and to access documents such as Notices of Award (NOA) and grant proposals.
PI	The Program Director/Principal Investigator directs a research project or program.
Postdoc	He/she serves in a postdoctoral role and can be someone who is being mentored and not yet in a permanent position.
Graduate	Graduate Student
Undergraduate	Individual in an undergraduate program
Sponsor	The Sponsor supervises the research training experience of individual fellows on fellowships.
Trainee	The trainee can be the recipient of an NIH fellowship (F series), a prebac, predoc or post doc on a NIH Training grant (T series) as well as a trainee on other types of NIH awards (e.g., K12, R25 among others). <u>See list of agencies in section II</u>. These funding agencies do not require users to register with the GCO in order to gain access to their online submission systems. However, the GCO receives an email to approve the new account once it is created. The GCO occasionally disapproves because of the use of a non-Mount Sinai email. Please do use your Mount Sinai email address when requesting access.

- V. Instructions: Principal Investigator (PI) Must Add a GCO Official to the On Line Application These funding agencies do not require users to register with the GCO in order to gain access to their online submission systems. PIs and other users register for an account directly with the funding agency. The PI must add the GCO Authorizing Official to their application or else the GCO cannot process the application. Please include the Authorized Organization Representative (AOR), which is the Authorizing Official, associated with your department, institute, or center from this listing.

- VI. Use of InfoEd to Directly Submit Single Project, Competitive Applications to the Federal Funding Agency

With the exception of the National Science Foundation (NSF) and NASA, all federal single project, competitive applications are prepared and submitted in InfoEd and sent directly to the agency. These are called System to System (S2S) applications. Users still need to register for accounts on the external online software system as per the instructions in this memo. However, do not log onto the agency's system to submit the applications. Please see Table 3 below for the applications that a PI submits using InfoEd.
