## Mount Sinai Pediatric Neurology Residency Program Icahn School of Medicine at Mount Sinai Teaching Conferences

## Mount Sinai Hospital / Kravis Children's Hospital

<u>Pediatric Neurology Core Curriculum Conference</u> is a weekly 1 hour conference held every Wednesday from 11a-12p and is a didactic lecture series given by rotating faculty within the Pediatric Neurology Division and affiliated faculty of the training program with expertise in their respective topics with the goal of covering the Pediatric Neurology Core Curriculum over the three years of residency training. It will be attended by all 2<sup>nd</sup> and 3<sup>rd</sup> year pediatric neurology residents, the 1<sup>st</sup> year resident when schedule permits on their adult neurology rotations, the 2 rotating adult neurology residents, as well as any rotating medical students on the Pediatric Neurology Service. A minimum of 3 pediatric neurology faculty will be in attendance to provide additional perspective on the topic presented on any given week from their clinical and/or research expertise.

<u>Neurology Core Curriculum Noon Conference</u> is a 1 hour lecture held daily from 12-1p in the Department of Neurology Yahr Library to cover the neurology residency program core curriculum. It is attended by all the adult neurology residents on site along which pediatric neurology residents in all three years of the training program will be required to attend.

<u>Pediatric Neurology/Child Psychiatry Joint Case Conference</u> is a bimonthly 1½ hour conference that will be held due to the frequent cross consultation of our respective clinical services. During this conference, a case will be presented by a pediatric neurology resident or child psychiatry fellow that focuses on neurological and/or psychiatric symptoms that overlap both disciplines. The case will then be discussed among the trainees and faculty from the perspective of our respective disciplines followed by a didactic session on the topic of focus led by one of the trainees.

<u>Pediatric Neurology & Neurosurgery Neuroimaging Conference</u> is a joint 1½ hour conference that will be held every 3 months and will be led by Dr. Thomas Naidich in Neuroradiology or rotating with other Neuroradiology faculty members. We will rotate the focus of this conference each month on either pediatric cerebrovascular cases (co-led by Dr. Alejandro Berenstein and Dr. Walter Molofsky), pediatric epilepsy cases (co-led by Dr. Saadi Ghatan and Drs. Lara Marcuse, Madeline Fields, and Maite Talbott), pediatric neuro-oncology cases (co-led by Dr. Peter Morgenstern and Dr. Praveen Raju), and pediatric neurogenetic cases (co-led by Dr. Praveen Raju and Dr. Isaac Marin-Valencia).

Residents will have opportunities to rotate through Neurology subspecialty specific teaching and clinical conferences during their elective rotations as well as during some required rotations as described below.
