As of May 18, 2020, the Financial Conflicts of Interest in Research training course has transitioned from PEAK to CITI Program (www.citiprogram.org). In the CITI Program site, be sure to add your **Mount Sinai email address** and **life number** to your institutional profile so that your certification date gets added to your project in eDisclosure Management System (eDMS - <https://edms.mssm.edu>). If you need to create a new account:

1. Click **Log In** (top right of the window)
2. Click "**LOG IN THROUGH MY INSTITUTION**"
3. Scroll and select "[Icahn School of Medicine at Mount Sinai](#)"
4. Type in your Mount Sinai Email Address and Password
5. Select "**I don't have a CITI Program account and I need to create one.**"
6. Click "**Create a New CITI Program Account**"

1. Click **Log In** (top right of the window)
2. Click "**LOG IN THROUGH MY INSTITUTION**"
3. Scroll and select "[Icahn School of Medicine at Mount Sinai](#)"

5. Select "**I already have a CITI Program account.**"
6. Enter your existing Username and Password to link your account to your Mount Sinai Credentials.
