Introduction

The MarketScan dataset hosted from the Windows operating system-based server is limited by computational memory, storage and CPU capacity, and thus computational performance on this server could not be guaranteed for a large number of concurrent users.

License fee

MarketScan data is **proprietary** and owned by [Merative](#). The institutional (Icahn School of Medicine) license is renewed annually in November, and the license fee is jointly covered by Scientific Computing and Data and individual research groups within the school, represented by the MarketScan user group.

- New users receive free-of-charge access for the initial 90 days once access is granted, thanks to the contribution of Scientific Computing and Data.

Thereafter, the access is subject to the shared access fee, and this is managed by the MarketScan user group leader, Dr. Parul Agarwal (parul.agarwal@mountsinai.org)

2. Upload the required certificates and completed Data Use Agreement to the request
3. An Active Account of the School (Icahn School of Medicine at Mount Sinai)
